A gift in your Will helps ensure we can continue to do this. **A legacy gift is easy to arrange, will not alter your current lifestyle and can be easily modified to address your changing needs.**

Gifts can be a sum of money, equities and bonds, property, a specific item or a share of what is left of your estate. Turner Contemporary is a registered charity so legacy gifts to us are exempt from inheritance tax thus reducing the overall amount of tax payable out of your estate. Further reductions in tax are available for those who leave 10 per cent or more of their estate to charity.

Unrestricted legacies create the biggest impact as they enable the gallery to apply your gift where it is most needed. Such gifts mean that you will make a lasting difference and Turner Contemporary will ensure future generations can have access to a world-class programme of exhibitions and events, alongside a groundbreaking participatory and learning programme.



If you are considering restricting your legacy to a specific area of our work, we would welcome the opportunity to discuss your plans with you before you commit them to a Will. This will help us to ensure that we are able to meet your wishes in the future.

Writing Your Will

There are few ways you can consider leaving a gift in your Will. We recommend that you consult a solicitor when writing or amending your Will to ensure that it reflects your intentions and is legally valid. They can also advise you about further matters such as Inheritance Tax.

Below is some suggested wording that your solicitor can use when writing your Will.

A Residuary Gift

A Residuary Gift is all or part of the value of your estate, once all your other commitments have been settled. When writing your Will, your solicitor can use the following wording:

“I give [state a proportion e.g. one third] of the residue of my estate to Turner Contemporary, based at Rendezvous, Margate, Kent CT9 1HG, UK, absolutely for its general charitable purposes to further its mission. My Trustees shall have no further duties relating to this benefit if they obtain a written receipt from an authorised officer.”

A Pecuniary Gift

A Pecuniary Gift is a specific sum of money. You may wish to protect this gift against the effects of inflation by asking your solicitor to ensure that it is index linked, which means that your specific sum would be adjusted according to an independent index, such as the UK Retail Price Index. When writing your Will, your solicitor can use the following wording:

“I give the sum of [amount in words] (£____ [amount in figures]) to Turner Contemporary based at Rendezvous, Margate, Kent CT9 1HG, UK, absolutely for its general charitable purposes to further its mission. My Trustees shall have no further duties relating to this benefit if they obtain a written receipt from an authorised officer.”

Amending Your Existing Will

If you have already made a Will but would like to leave a gift to Turner Contemporary, you can still do so by writing a codicil. The following wording can be adapted by your solicitor to suit the type of gift you wish to leave.

“I [full name] of [full address] declare this to be a [first/second/etc.] codicil to my Will dated [day] [month] [year]. In addition to any legacies given in my said Will, I give, devise and bequeath to Turner Contemporary of Rendezvous, Margate, Kent CT9 1HG, UK [the whole (or ____% share) of my residuary estate] or [the sum of ____ (____ pounds)] absolutely for its general charitable purposes to further its mission. My Trustees shall have no further duties relating to this benefit if they obtain a written receipt from an authorised officer. In all other respects I confirm my said Will and any other codicils thereto.”
